### NOTE BY THE DIRECTOR-GENERAL

### CALL FOR NOMINATIONS FOR THE FIFTH OFFICIAL OPCW BIOMEDICAL PROFICIENCY TEST

- 1. The Director-General wishes to inform OPCW Member States of the schedule and arrangements for the Fifth Official OPCW Biomedical Proficiency Test.
- 2. For the Fifth Official OPCW Biomedical Proficiency Test, Lawrence Livermore National Laboratory, the United States of America, will prepare the test samples and DGA Maîtrise NRBC, Département Analyse Chimique, France will assist in the evaluation of the results. The anticipated sample dispatch date is 21 February 2020, and the samples will be shipped to the test participants by the OPCW Laboratory.
- 3. Member States are invited to nominate laboratories that are interested and/or have expertise in the analysis of biomedical samples to participate in the test. Nominations should be sent to the OPCW Laboratory via email (biopt@opcw.org) no later than 31 January 2020.
- 4. Nominations should contain:
  - (a) the full name and address of the laboratory;
  - (b) the detailed sample delivery address (if different from the laboratory address);
  - (c) the name, telephone number, and email address of the laboratory contact person; and
  - (d) any other special requirements or information needed to ensure sample delivery.
- 5. The nomination form that is annexed to this document may be used for submitting the nominations.
- 6. In order to confirm participation in the Fifth Official Biomedical Proficiency Test, previous test participants must, where required, submit to the OPCW Laboratory, **before 31 January 2020**, their follow-up report stating the cause of the problem and the remedial actions they have taken as a result of their participation in the last biomedical proficiency test. Early submission of such reports is strongly encouraged.
- 7. For the Fifth Official Biomedical Proficiency Test, participating laboratories are requested to submit analysis reports within 15 calendar days of receiving the samples.

- 8. Participating laboratories are also requested to contact the OPCW Laboratory by email (biopt@opcw.org) before the sample dispatch date to confirm their contact details for the delivery of the test samples.
- 9. Finally, participating laboratories are requested to arrange internal customs clearance procedures for the samples in order to prevent any unnecessary delays in the sample delivery process.
- 10. The Fifth Official OPCW Biomedical Proficiency Test will be conducted in accordance with the following set of quality management system documents:
  - (a) "Standard Operating Procedure for the Organisation of OPCW Biomedical Proficiency Tests" (QDOC/LAB/SOP/BioPT01);
  - (b) "Work Instruction for the Preparation of Samples for OPCW Biomedical Proficiency Tests" (QDOC/LAB/WI/BioPT02);
  - (c) "Work Instruction for the Evaluation of the Results of OPCW Biomedical Proficiency Tests" (QDOC/LAB/WI/BioPT03); and
  - (d) "Work Instruction for the Reporting of the Results of the OPCW Biomedical Proficiency Tests" (QDOC/LAB/WI/BioPT04).
- 11. A meeting to discuss the preliminary results of the Fifth Official OPCW Biomedical Proficiency Test has been tentatively scheduled for 15 July 2020 at the OPCW Headquarters in The Hague, the Netherlands.
